### Learning Rx Opens Office in Downtown Great Bend

When Julie Stuhlsatz, Great Bend, first discovered LearningRx, she could have had no way of knowing the effect it would have on her family. Not only did her son's school and home life

improve but Stuhlsatz also is now the manager and head trainer for the new LearningRx office in Great Bend, 2015 Forest, Suite 106. The business celebrated its grand opening in July.

LearningRx helps clients build cognitive skills in areas such as attention, memory, thinking speed, and math and reading skills. It uses one-on-one brain training. "My son took the cognitive skills test through the ThinkRx program that we offer," Stuhlsatz said. "This core program, which is one of several we offer, focuses on long- and short-term memory, visual processing, logic and reasoning, auditory processing and other skills.



"He improved the age equivalency of four years in long-term memory, and logic and reasoning skills," she continued. "And he did this in three months."

Her son doesn't spend nearly as much time as he did before on his schoolwork, and learning comes easier for him now. "Before LearningRx, his weekly test preparation was lengthy and not always successful," his mother explained. "Now his test-preparation time is shorter, more enjoyable and more successful. He also demonstrates more self-confidence and independence in the classroom and everyday life."

The main Kansas office is in Hutchinson and the Great Bend location is the second site in the state. Stuhlsatz is one of two local trainers. LeAnna Lugafet, owner and director, noted that Stuhlsatz was instrumental in starting this new venture because she wants to help other families in central Kansas. "Some people come to us because they strive to be better at school or prepare for college," Lugafet said. "Older people often want help with memory issues. But many come because of ADHD or dyslexia, or math, reading and other learning struggles.

LearningRx is a nationwide company with more than 80 locations; it serves all ages, beginning at age 4. Initial cognitive testing and the follow-up consultation are performed at the Hutchinson office but the actual brain training is in Great Bend. ### St. Rose Expands OB-GYN Hours in Great Bend

Haley Gleason and her colleagues at St. Rose Health Center realize families face scheduling difficulties when trying to juggle OB-GYN appointments so that family members can attend too. Therefore, Gleason and two other specialists will have expanded Thursday hours to accommodate fathers and other loved ones, and will be open from noon to 7 p.m.

"Not only does this include the traditional lunch hour but the time between 4 and 7 p.m. will be especially attractive to families," said Gleason, advanced practice registered nurse. "We hope this promotes more family involvement."

Services include low-risk OB follow-ups; OB-GYN post-operative exams; fetal heart monitoring; and ultrasounds, including Hello Baby 4D procedures. Gleason also will offer pelvic exams and PAPs during the expanded hours. In addition to Gleason, the women's health team includes Lacey Kern, registered diagnostic medical sonographer; and Melanie Krier, BSN, RN, who is certified in advanced fetal heart monitoring. All three work in conjunction with OB-GYNs at Hays Medical Center, the sole owner of St. Rose. These physicians are Joel Fort, M.D.; Lee Hodny, M.D.; and Timothy Hoskins, M.D. Each of these physicians sees patients weekly at the HaysMed Specialty Clinic at St. Rose. When Diane Olsen, R.N., was seeing hospice patients in Great Bend, she visited Cherry Village Benevolence and helped care for its residents nearing the end of life.

Now, she is the new director of nursing at the non-profit, short- and long-term-care facility at 1401 Cherry Lane.

"I was here at Cherry Village often during the three years I cared for hospice patients," Olsen said. "I always liked the facility, and I respect Pam Lewis and her mission."

Lewis is Cherry Village administrator; Olsen previously worked for Hospice Care of Kansas, now known as Kindred Hospice. In her new position, Olsen is using her decades of





experience "to ensure all our residents are safe and happy, and that we meet all their physical and emotional needs.

"We want Cherry Village to be as home-like as possible," she added. "Residents deserve professional and compassionate care, with the best quality of life possible. I emphasize that we consider the whole resident in all that we do."

Olsen's background includes positions at the Mayo Clinic's Rochester Methodist Hospital for 12 years and the former Central Kansas Medical Center (CKMC) in Great Bend for four years. She also was a nurse at facilities in California.

"I moved to Great Bend with my 8-week-old baby to be near family in 1993," Olsen recalled, noting she is originally from Iowa. "I have run the gamut in nursing, starting as an aide before spending many years in acute and chronic renal dialysis and a number of other specialties."

Olsen also has been an emergency room nurse and managed a gastro-intestinal lab. She was at CKMC from 1993-97, when she served patients in the skilled-nursing unit and in scheduling.

Her list of responsibilities at Cherry Village includes: managing all residents' care; overseeing medications and doctors' orders; managing the nursing staff; and complying with all state and federal regulations.

In addition, Olsen is available for individual and group tours, and for speaking engagements. "I would love to have church, civic and school groups come into Cherry Village and share time with our residents. I also would enjoy speaking at their meetings."
