# HUMAN RESOURCES UPDATE -Minimum Salary Level Increases Jan. 1st

Many employers may remember the proposed change to the minimum salary level that was expected in 2016 (hard to believe that was three years ago). At the eleventh hour, it was delayed, and then later cancelled entirely, unfortunately after many employers had already made and communicated changes to their employees.



Now the government has announced another try at a final rule change, to take effect January 1, 2020. Fortunately, this one is a little more reasonable than the 2016 version, and seems much more likely to actually take effect.

The new rule will raise the salary threshold to \$684 a week (\$35,568 annualized) from \$455 a week (\$23,660 annualized). If you have employees who are fully salaried (that is to say, exempt from the overtime rules), you'll need to consider the impact of this change on your business.

Under the new rule, nondiscretionary bonuses and incentive payments (including commissions) paid on an annual or more frequent basis may be used to satisfy up to 10 percent of the standard salary level. The new rule also does not include scheduled increases to the level (as the 2016 version did), but the Department of Labor has expressed an intention to raise the level more regularly than in the past.

#### What to Do Now:

- 1. Review job descriptions to ensure employees are correctly classified.
- 2. For positions close to the threshold, weigh the cost of raising employee salaries above the new threshold against the cost of reclassifying employees as nonexempt and paying overtime.
- 3. For positions that will need to change to nonexempt, develop a training and communication strategy for the transition.

Be aware that paying an employee on a salary basis is not a matter of convenience - the position must qualify for an exemption based on the job duties. Does the person supervise others, for example? There are a number of exemptions available for executive, administrative, professional and other types of positions, but getting it right is very important, as the penalties can be significant. If there is any doubt, it is much safer to pay overtime.

Todd and Amanda VanSkike knew that their first year as business owners might not be easy, but all their hard work is paying off now as they look back on a successful first year owning Golden Belt Bicycle Company in downtown Great Bend. "I knew I wanted to work with bikes. I had worked in the bike shop since 2008 and I'm passionate about cycling and building custom bikes," Todd says. "But when the shop was for sale, we had talked to numerous banks and we didn't have the collateral to meet traditional financing requirements. And that's where CKDI came in."

The young couple were relieved to find out about Central Kansas Development Inc, a for-profit investment company in Central Kansas that exists to promote economic development through gap financing and non-traditional business loans. "Not only was getting the loan from CKDI so much easier than the traditional loan programs, but it was also great to have someone to hold our hand for the first year in business," Amanda VanSkike says. "The board members met with us monthly, and helped us think through big decisions and plan for the future. They pointed out things we wouldn't have thought of, and it was great to have their expertise in our corner."

Central Kansas Development Inc (CKDI) was founded more than 60 years ago to promote economic development by financing new opportunities for entrepreneurs and business leaders in Central Kansas. Since the 1950s, the group has helped dozens of companies expand their operations, purchase new equipment, acquire real estate, and overcome barriers keeping them from growth and success. "More than 20 percent of small businesses fail in their first year, and 30% fail in the second year. CKDI exists to provide confidential financing, but also to help ensure the success of the businesses we partner with through mentorship," says Barry Bowers, CKDI Board President. # Aster Estates Offers New Senior Living Option - Opens this Fall in Great Bend

About a week after Pam Lewis retired from Cherry Village, a long-term-care residence in Great Bend, her 97-year-old mother fell and broke her arm. Doris Johansen, who is now 98, stayed in a nursing home for a short time but when she returned home Lewis moved in with her. "Mom didn't need 24/7 nursing care but needed help with meals, laundry, housekeeping and other day-to-day tasks," Lewis said. "I soon realized that other people are in similar situations."

One thing led to another and Lewis will open Aster Estates this fall at 155 NW 10th Ave., a short distance from the city limits on the west side of North McKinley.

Lewis, a registered nurse, and her mom plan to make their home at Aster Estates, which provides a "living style that promotes and supports independence, with caring professionals and para-professionals on staff," Lewis said. "This model of care is often referred to as 'home plus.'



"We are hiring several care professionals to help with tasks that don't require a registered nurse. Our nurse's aides, medication aides, and a licensed practical nurse or RN will always be on hand to help.

Aster Estates' residential capacity is eight people in the almost 3,600 square feet of living space. The basement, which has more than 2,600 square feet, will be home to staff offices. To enjoy all amenities, residents must be ambulatory on their own or with a walker, and be able to stand and walk with minimal assistance. Everyone will have a private suite; most suites have either full baths or half baths. The home, including all bathrooms, has been extensively remodeled.

Other Aster Estates features include: three home-cooked meals a day, and snacks; a swimming pool for water aerobics and relaxation with supervision; outdoor pool table and firepit; and large outdoor sitting/activity area. "We encourage people to join in activities and get involved in helping with meal preparation, if they are so inclined," Lewis said. "However, we understand that sometimes residents just want their privacy. We respect that too."

In addition, staff members are available to take residents to medical appointments. "We realize that family members don't always live close by," Lewis commented. "If the resident chooses, we will provide transportation and attend appointments to ask questions and alleviate the stress of doctors' visits."

Lewis retired from Cherry Village in July of 2018. "It became difficult to focus on resident care as a stand-alone non-profit facility. I felt as if the volumes of regulations were forcing me to choose between residents' needs and regulations."

Lewis and her family have been involved in the care of elders for nearly 50 years. Aster Estates is licensed by the Kansas Department for Aging and Disability Services. "Yes, the state will monitor us, as it should," Lewis said. "But the federal government is not making decisions about how people in Great Bend live their lives."

Erin Lewis, Pam's daughter-in-law, worked at Cherry Village and is now the business manager at Aster Estates.

"We want everyone to feel at home; that is the most important thing," Erin said. "We don't want anyone to feel like they have been stuck somewhere without having a purpose in life. This is a setting as much like home as we can possibly make it."

Remodeling began soon after the purchase of the house in February. An architect and designer were involved, and Just In Time Remodeling, 1311 Williams, has handled the job from start to finish. "They have been great to work with and the house is so light and airy now," Erin commented. "We have all collaborated to marry the comfort of home with individualized care and service. Each resident will enjoy personal attention."

# **Sunflower Div. Remodels Recycling Center**

The recent remodeling project at Sunflower Recycling has given the staff extra elbow room in a more efficient setting. Sunflower Diversified Services operates the drop-off site at 5523 10th, Great Bend, as part of its multi-faceted recycling operation.

The non-profit agency serves people with intellectual disabilities and delays in central Kansas. Sixty-one clients at Sunflower work in recycling. "We wanted to make the setting more efficient for the staff and customers at the drop-off site," said Jon Prescott, Sunflower executive director. "We expect the operation to grow and want to be better prepared.

"For example, we are looking at the possibility of new equipment to enable us to process more glass."

The remodeling project included: moving excess items to storage at the recycling processing plant near the airport; and the installation of an industrial water cooler for better climate control. "Our major recycling goal is to create more jobs for clients," Prescott said. "Many of the folks we serve are able to work and want to work for their own paychecks."

Currently, an average of 100 vehicles visit the center on 10th Street each day. However, this is only part of the recycling operation. Sunflower also offers a drop-off trailer at 18th and Williams, and serves hundreds of businesses on pickup routes. The materials are taken to the processing plant for shipment. "Any extra revenue we make from this operation goes directly to the people we serve," Prescott noted. "This could be in the form of new jobs, services and equipment. Every penny stays in our local five-county service area."

The executive director also pointed out that a board of directors governs the non-profit agency and determines how funds are spent. "Our great volunteer board always looks for ways to increase revenues in recycling and other areas so we can enhance services," Prescott said. "Board members are good stewards of tax dollars and crucial private donations that allow us to serve children and adults.

"As a non-profit entity, Sunflower does not have stockholders who expect dividend checks. The only stockholders we have are the people we serve."

Sunflower became responsible for all recycling management and daily operations in January 2000. The dropoff center's hours are 9 a.m. to 6 p.m. weekdays and 9 a.m. to 1 p.m. Saturdays.

Clara Barton Hospital was awarded \$4,350 to help provide a course redesign and upgrade to the current Disc Golf course in Hoisington. The Hoisington Recreation Commission supports this project and has contributed \$5,000. The grant will help provide 9 new Dynamic Discs Veteran baskets, 9 new disc tee signs as well as some new course signage. A professional designer will be used to redesign the layout of the current outdated course. The course will be designed to be safe, environmentally friendly and tournament ready. Dynamic Discs who designed the course at Vets Park will be used for this project to ensure the course layouts complement each other.

Friends of Recovery was awarded \$2,500 to provide a part-time program coordinator in Great Bend to help open new houses and support the house with case management, including mediation and education. Specifically, this will include understanding Medication Assisted Treatment, new member orientation, trauma informed care workshops, parenting classes to the Oxford Houses and education to the community on addiction, recovery and the Oxford Houses. The Oxford Houses serve the homeless and near-homeless who are in recovery from alcohol and drug addition with transitional housing.

Barton County Emergency Aid was awarded \$4,618 to support rent and utility assistance along with aid to the homeless and transients. Financial support is also given to RSVP to aid in transport of those in need to appointments. The goal of emergency aid is to provide aid to those who are in an 'emergency state' of being evicted due to inability to pay rent or utilities being shut off due to nonpayment. Assistance is also offered to the homeless and transients.
