Breaking Ground on Innovation: Great Bend Celebrates the IGNITE Innovation Center

The Great Bend Economic Development team held a groundbreaking ceremony for the highly anticipated IGNITE Innovation Center, Thursday, December 12th. The event took place at the site of the future center, located at the frontage lot on Farmers Plaza at K-96 and 10th Street.

This milestone marks the beginning of a project years in the making, designed to foster innovation, entrepreneurship, workforce development, and community growth. The event will feature a ceremonial shovel dig and remarks from Ryan Fairchild, Vice Chair of Great Bend Economic Development. Dignitaries from the City, Barton County, partners, and board members have been invited to participate.

The Innovation Center, with an estimated budget of \$7 million, is already threequarters funded through grants and donations. It will include:

• Fab Lab: A makerspace equipped with 3D printers, flight simulators, drones, plasma cutters, CNC machines, welders, and more.

• Commercial Kitchen: Supporting childcare providers, startup restaurant incubators, and cooking classes.

· Leafy Green Farm Pod: Engaging youth in agriculture and entrepreneurship.

Co-Working Space and Computer Lab: For remote workers, students, and community members.

Childcare Rooms: Providing care for



shift workers during nontraditional hours.

• Meeting Rooms and Podcast Studio: Equipped with high-tech resources for training and content creation.

"We are committed to creating opportunities and inspiring growth in Barton County," said Sara Arnberger. "The Innovation Center is a testament to our dedication to the community's future."

GBCF Giving Tuesday Campaign raises over \$500,000 for area non-profits

Golden Belt Community Foundation just completed its eleventh Giving Tuesday campaign, wrapping up and announcing the results during a Great Bend Chamber of Commerce Coffee.

Giving Tuesday started as a day for anyone, anywhere to give, and it has grown into the biggest giving movement in the world. Giving Tuesday harnesses the generosity of millions of people around the world to support the causes they believe in and the communities in which they live.

Celebrated on the Tuesday following U.S. Thanksgiving, Giving Tuesday inspires millions of people across the globe to show up and give back to causes and issues that matter to them.

This year over 1,000 gifts were made to support 115 local charitable organizations and endowment funds raising a total of \$533,217.00.

"This year marked GBCF's 11 th year to be a Giving Tuesday partner," stated Mackenzie Mitchell, Development and Communications Coordinator, "and again this year we invited all charitable organizations in Barton, Pawnee, Rush, and Stafford counties to participate."

Mitchell further explained that there were a handful of new organizations participating, and that each organization chose whether to get any gifts received as a grant back to their organization – or to use the gifts to build their endowment fund at GBCF. Many organizations will be receiving the gifts as grants to be put to immediate use supporting a wide variety of missions and causes.

"Today GBCF will be awarding over \$500,000 in grants," Mitchell explained. The 2024 Top Ten Giving Tuesday organizations and funds raised are:

"Thank you for your support, participation, and spreading the word about Giving Tuesday", said Jason Murray. "Giving Tuesday couldn't happen without you".

The Most Generous City Award, which was calculated with gift totals by zip code per capita. Great Bend received the 2024 Most Generous City award, and the foundation will make a grant of \$1,000 to an organization or project in that community.

In 2025 Giving Tuesday will be celebrated on December 2nd.

Court Reinstates BOI Filing Requirement & then Blocks it Again

The ongoing legal battle surrounding Beneficial Ownership Information (BOI) reporting has created uncertainty for business owners. Here's the latest:

Dec. 3, 2024: The Eastern Texas District Court placed an injunction on the Corporate Transparency Act (CTA), preventing FinCEN from enforcing BOI filing requirements.

Dec. 23, 2024: The fifth Circuit Court of Appeals stayed the Texas court's injunction, briefly reinstating the BOI reporting requirement. FinCEN responded by extending the filing deadline for businesses formed before 2024 from Jan. 1, 2025, to Jan. 13, 2025.

Dec. 26, 2024: The court reversed course again, lifting its stay and blocking enforcement of the filing requirement until further notice.

What this Means for Business Owners

businesses should:

Stav Prepared: If you have not vet filed your report, continue gathering the necessary information to file your BOI report. Deadlines could be reinstated with little notice.

Consider Voluntary Filing: While not Monitor Updates: This legal back-and-

Therapist Promotes Balance in New Year's Resolutions Through DBT

Jessica Blehm, a therapist at The Center for Counseling & Consultation in Great Bend, emphasizes the importance of balance when setting New Year's resolutions. She recommends Dialectical Behavior Therapy (DBT) as a valuable tool to support positive change. DBT focuses on finding a middle ground between emotional and rational thinking and incorporates four core skills: mindfulness, distress tolerance, emotional regulation, and interpersonal interaction. These skills are suitable for individuals of all ages and can help build a framework for managing life's challenges.

Mindfulness encourages awareness of thoughts and feelings, helping individuals stay motivated by focusing on the meaningful outcomes of their actions rather than the tasks themselves. Distress tolerance, another key skill, teaches people to navigate difficult moments without impulsive reactions, whether it's resisting the urge to stay in bed, managing anger, or avoiding harmful behaviors. These tools enable individuals to step back, evaluate priorities, and handle stress more effectively.

Emotional regulation involves consciously changing thoughts and behaviors to influence emotions positively. For instance, altering routines or perspectives can lead to different emotional responses. Interpersonal skills focus on setting boundaries, improving communication, and listening effectively, which can enhance relationships and personal growth. The word "dialectical" reflects DBT's acknowledgment of the coexistence of opposites, such as loving someone while feeling anger toward them.

Blehm advises approaching resolutions with self-compassion and realistic goals, avoiding the overwhelm that comes from trying to change too much at once.
